CONSENT AGREEMENT

This Consent Agreement, dated this ~~8th~~ ^{14th Cite} day of December, 2006, is between the State Board of Veterinary Medical Examiners ("Board") and Dina K. Jones, D.V.M., ("Dr Jones"), License No. 4606. The Agreement concerns the charges that the Board filed against Dr. Jones alleging that she practiced veterinary medicine in this State during a time period that she was not registered as a licensed veterinarian in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland.

Under State law, the Board is the licensing authority responsible for regulating the practice of veterinary medicine in this State, which includes filing disciplinary actions against veterinarians charged with violating the provisions of the Veterinary Practice Act and regulations adopted thereunder. The Board "may refuse, suspend, or revoke any application or license, and censure or place on probation any licensee ... if the veterinarian ... [f]ails to comply with [the Veterinary Practice Act and] Board rules and regulations after receiving a license" (Md. Code Ann., Agric. Art., §2-310(8)); and in lieu of, or in addition to, suspending a veterinarian's license, the Board may impose a civil penalty of not more than \$5,000 (Md. Code Ann., Agric. Art., §2-310.1).

FINDINGS OF FACTS

Dr. Jones, by entering into and signing this document, acknowledges that the Board could produce evidence establishing the following Findings of Fact:

1. On or about July 1, 2006 through October 23, 2006 of the 2006-7 Licensing Year (July 1, 2006 through June 30, 2007), Dr. Jones practiced veterinary medicine at the Triadelphia Veterinary Clinic located at 3900 Ten Oaks Road, Glenelg, MD 21737.

During this time period, however, Dr. Jones was not registered to practice as a licensed veterinarian in this State.

2. On June 30, 2006, Dr. Jones' registration for the 2006-7 Licensing Year expired. She failed to take steps on or before that date to renew it.
3. On or about October 23, 2006, Ms. Robin Roscher, an Inspector with the Board, obtained medical records from the Triadelphia Veterinary Clinic, showing that Dr. Jones treated animals at this facility during the period that her registration had lapsed (July 1, 2006 through October 23, 2006).
4. Dr. Jones has since taken steps to renew her registration for the 2006-7 Licensing Year.

CONCLUSIONS OF LAW

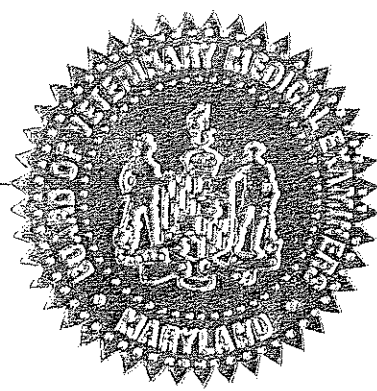
Based upon these Findings of Fact, the Board makes the following Conclusion of Law: On or about July 1, 2006 through October 23, 2006, Dr. Jones practiced veterinary medicine at the Triadelphia Veterinary Clinic located at 3900 Ten Oaks Road, Glenelg, MD 21737, but, during this time period, was not registered as a licensed veterinarian in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, finding that Dr. Jones violated the Veterinary Practice Act, it is this ^{14th CHZ} 5 day of December, 2006, by the State Board of Veterinary Medical Examiners, **ORDERED:**

That Dr. Jones is assessed a Civil Penalty in the amount of Two Hundred and Fifty Dollars (\$250.00) and that she pay this penalty to the Board within thirty (30) days from the date of this Consent Agreement.
