CONSENT AGREEMENT

This Consent Agreement, dated this ^{27th CHR} 17 day of February, 2007, is between the State Board of Veterinary Medical Examiners ("Board") and Gary S. Gross, D.V.M., License No. ~~4606~~ ^{1464 CHR 2/27/07}. The Agreement concerns the charges that the Board filed against Dr. Gross alleging that he practiced veterinary medicine in this State during a period that he was not registered as a licensed veterinarian in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland.

Under State law, the Board is the licensing authority responsible for regulating the practice of veterinary medicine in this State, which includes filing disciplinary actions against veterinarians charged with violating the provisions of the Veterinary Practice Act and regulations adopted thereunder. The Board "may refuse, suspend, or revoke any application or license, and censure or place on probation any licensee ... if the veterinarian ... [f]ails to comply with [the Veterinary Practice Act and] Board rules and regulations after receiving a license" (Md. Code Ann., Agric. Art., §2-310(8)); and in lieu of, or in addition to, suspending a veterinarian's license, the Board may impose a civil penalty of not more than \$5,000 (Md. Code Ann., Agric. Art., §2-310.1).

FINDINGS OF FACTS

Dr. Gross, by entering into and signing this document, acknowledges that the Board could produce evidence establishing the following Findings of Fact:

1. On or about July 1, 2006 through October 11, 2006 of the 2006-7 Licensing Year (July 1, 2006 through June 30, 2007), Dr. Gross practiced veterinary medicine at the

Hickory Ridge Animal Hospital, located at 10328 Owen Brown Road, Columbia, MD 21044. During this time period, however, Dr. Gross was not registered to practice as a licensed veterinarian in this State.

2. On June 30, 2006, Dr. Gross' registration for the 2006-7 Licensing Year expired. He failed to take steps on or before that date to renew it.
3. On or about October 11, 2006, Ms. Robin Roscher, an Inspector with the Board, obtained medical records from Hickory Ridge Animal Hospital; showing that Dr. Gross treated animals at this facility during the period that his registration had lapsed (July 1, 2006 through October 11, 2006).
4. Dr. Gross has since taken steps to renew his registration for the 2006-7 Licensing Year.

CONCLUSION OF LAW

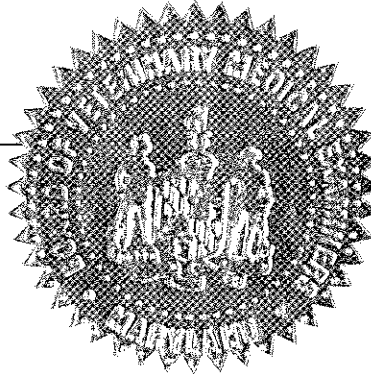
On or about July 1, 2006 and through October 11, 2006, Dr. Gross practiced veterinary medicine at the Hickory Ridge Animal Hospital, located at 10328 Owen Brown Road, Columbia, Maryland 21044, but during this time period, was not registered as a licensed veterinarian in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, finding that Dr. Gross violated the Veterinary Practice Act, it is this 27th day of February, 2007, by the State Board of Veterinary Medical Examiners, **ORDERED**:

That Dr. Gross is assessed a Civil Penalty in the amount of Two Hundred Dollars (\$200.00) and that he pay this penalty to the Board within thirty (30) days from the date of this Consent Agreement.


