CONSENT AGREEMENT

This Consent Agreement, dated this ¹²~~12~~ day of February, 2007, is between the State Board of Veterinary Medical Examiners ("Board") and Barbara A. Kummel, D.V.M. ("Dr Kummel"), License No. 2244. The Agreement concerns the charges that the Board filed against Dr. Kummel alleging that she practiced veterinary medicine in this State during a time period that she was not registered as a licensed veterinarian in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland.

Under State law, the Board is the licensing authority responsible for regulating the practice of veterinary medicine in this State, which includes filing disciplinary actions against veterinarians charged with violating the provisions of the Veterinary Practice Act and regulations adopted thereunder. The Board "may refuse, suspend, or revoke any application or license, and censure or place on probation any licensee ... if the veterinarian ... [f]ails to comply with [the Veterinary Practice Act and] Board rules and regulations after receiving a license" (Md. Code Ann., Agric. Art., §2-310(8)); and in lieu of, or in addition to, suspending a veterinarian's license, the Board may impose a civil penalty of not more than \$5,000 (Md. Code Ann., Agric. Art., §2-310.1).

FINDINGS OF FACTS

Dr. Kummel, by entering into and signing this document, acknowledges that the Board could produce evidence establishing the following Findings of Fact:

1. On or about July 1, 2006 through December 7, 2006 of the 2006-7 Licensing Year (July 1, 2006 through June 30, 2007), Dr. Kummel practiced veterinary medicine at

Animal Skin Disease Clinic, located at 7410 Lindbergh Drive, Gaithersburg, MD 20879. During this time period, however, Dr. Kummel was not registered to practice as a licensed veterinarian in this State.

2. On June 30, 2006, Dr. Kummel's registration for the 2005-6 Licensing Year expired. She failed to take steps on or before that date to renew it for the 2006-7 Licensing Year (July 1, 2006 through June 30, 2007).

3. On or about December 5, 2006, Ms. Beverly Raymond, an Inspector with the Board, obtained medical records from Animal Skin Disease Clinic, showing that Dr. Kummel treated animals at this facility during the period that her registration had lapsed (July 1, 2006 through December 4, 2006).

4. Dr. Kummel has since taken steps to renew her registration for the 2006-7 Licensing Year.

CONCLUSIONS OF LAW

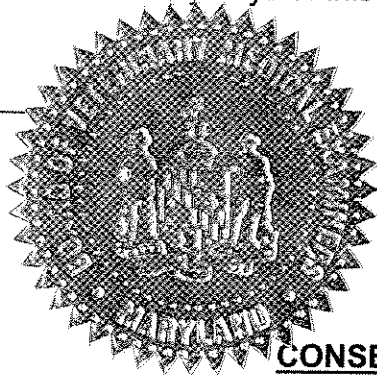
Based upon these Findings of Fact, the Board makes the following Conclusion of Law: On or about July 1, 2006 through December 4, 2006, Dr. Kummel practiced veterinary medicine at Animal Skin Disease Clinic, located at 7410 Lindbergh Drive, Gaithersburg, MD 20879, but during this time period, was not registered as a licensed veterinarian in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland, and COMAR 15.14.01.11.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, finding that Dr. Kummel violated the Veterinary Practice Act, it is this ^{12²²} day of February, 2007, by the State Board of Veterinary Medical Examiners, **ORDERED:**

That Dr. Kummel is assessed a Civil Penalty in the amount of Three Hundred Dollars (\$300.00), to be paid within thirty days of this agreement.
