CONSENT AGREEMENT

This Consent Agreement, dated this 27th day of January, 2005, is between the State Board of Veterinary Medical Examiners ("Board") and W. Conrad Filsinger, D.V.M., License No. 1234. The Agreement concerns the complaint that Ms. Patty Dewalt filed against Dr. Filsinger, alleging, among other things, that she presented her dog, "Walker," an eight-year old Gordon Setter, to Dr. Filsinger for grooming, and that, to perform this task, he administered an anesthetic agent to the dog (that being, a Ketaset/Xylazine combination), without her permission.

Under the Veterinary Practice Act, the Board "may refuse, suspend, or revoke any application or license, and censure or place on probation any licensee ... if the veterinarian ... [f]ails to comply with Board ... regulations after receiving a license" (Md. Code Ann., Agric. Art., §2-310(8)); and in lieu of, or in addition to, suspending a veterinarian's license, the Board may impose a civil penalty of not more than \$5,000 (Md. Code Ann., Agric. Art., §2-310.1).

In this matter, the Board charged, among other things, that Dr. Filsinger failed to conform to those minimal standards of care and treatment which are customary among veterinarians in this State, a violation of COMAR 15.14.01.07, by failing to physically examine Walker before administering the Ketaset/Xylazine combination to gauge the risk this drug combination posed to him.

FINDINGS OF FACT

Dr. Filsinger, by entering into and signing this document, stipulates to, and acknowledges that the Board, by a preponderance of the evidence, could prove the following Findings of Fact:

1. At all times relevant to the charges, Dr. Filsinger was, and is, a veterinarian licensed to practice veterinary medicine in the State of Maryland.
2. On or about March 3, 2004, Patty Dewalt presented her dog, Walker, an eight-year old Gordon Setter, to Dr. Filsinger, the owner of Potomac Valley Animal Hospital, for grooming. Ms. Dewalt was new to the area, and had never taken her dog to Dr. Filsinger or his facility.
3. When Ms. Dewalt presented her dog, she informed Dr. Filsinger that Walker did not like his hindquarters brushed. Dr. Filsinger advised that if Walker bites, he would sedate the dog.
4. In the patient's record, Dr. Filsinger noted that Walker did not allow "combing near his back area" and had "tried to bite." Dr. Filsinger also noted that he "had to sedate" Walker, and that he administered the following drug combination to the dog: "Ketaset 1 cc IM (100 mg/ml) + Xylazine 20 mg IM." Ketaset is a rapid acting agent whose pharmacologic action is characterized by profound analgesia, immobilization, normal pharyngeal-laryngeal reflexes, mild cardiac stimulation, and respiratory depression. Xylazine is an α -2 agonist, providing analgesia and sedation. Xylazine may induce profound cardiovascular changes (e.g., bradycardia, second-degree heart block, and hypotension, following a brief period of hypertension). Therefore, the combination of Ketamine/Xylazine may be associated with significant cardiovascular and respiratory side effects.
5. Dr. Filsinger estimated Walker's weight to be approximately 100-110 pounds. Dr. Filsinger did not physically examine Walker before administering this drug combination to the dog. In addition, Dr. Filsinger did not contact the owner to provide her the option of granting or declining permission to perform bloodwork on Walker to further gauge the risk this drug combination posed to her dog.

CONCLUSIONS OF LAW

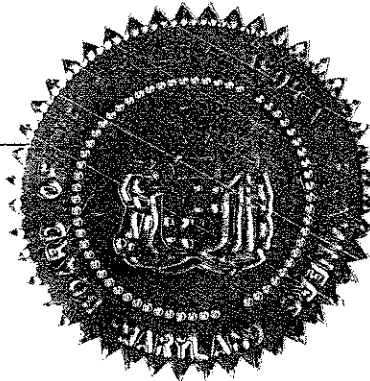
1. In failing to physically examine Walker before administering the Ketaset/Xylazine combination to gauge the risk this drug combination posed to him, particularly given that Walker was an older dog, and had not been previously seen in his practice, Dr. Filsinger's care fell below the minimal standard expected of a practitioner in this State, a violation of COMAR 15.14.01.07.

2. In failing to contact the owner to provide her the option of granting or declining permission to perform bloodwork on Walker before administering the Ketaset/Xylazine combination to further gauge the risk this drug combination posed, particularly given that Walker was an older dog, and had not been previously seen in his practice, Dr. Filsinger's care fell below the minimal standard expected of a practitioner in this State, a violation of COMAR 15.14.01.07.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, finding that W. Conrad Filsinger, D.V.M. violated COMAR 15.14.01.07, it is this 27th day of January, 2005, by the State Board of Veterinary Medical Examiners, **ORDERED:** That Dr. Filsinger pay a civil penalty in the amount of five hundred dollars (\$500.00) (the Board acknowledges that Dr. Filsinger already has paid this penalty).

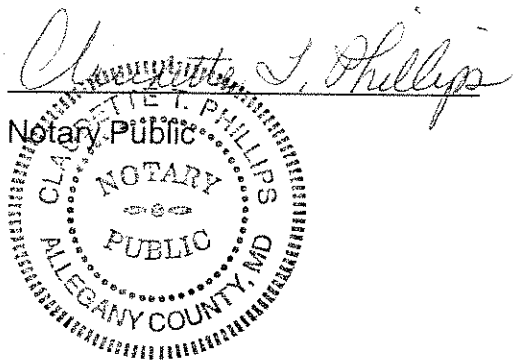
